"I am aware of the inherent risk associated with fishing and boating, including but not limited to the risks of collisions with other boats and stationary objects in and around the lake, including rocks, reefs or piers or other vehicles and trailers at landing areas. I am familiar with other risks up to and including death by drowning associated with rough water, changing weather patterns, heavy winds and lightning storms. I expressly assume all risks associated with this tournament and I hereby release Muskies, Inc. International and Headwaters Chapter of Muskies, Inc., the host, sponsors, and tournament officials from all claims of negligence resulting from injury and/or property damages incurred in connection with the tournament."
2. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of those persons released from liability below, and assume full responsibility for my participation; and
3. I will comply with all rules and regulations. If I have any question, or observe any unusual or unnecessary hazard during my participation, I will immediately bring such to the attention of the nearest official; and

This tournament was started years ago by Paul Riedel Sr. with the intent of bringing fishermen and women together to enjoy the beautiful Eagle River Chain of Lakes, comradery between fishermen, a chance to win some money and to raise money for local charities. Paul's Pro Arn was known as one of biggest and best tournaments around for many years. Paul did a great job at setting the standard for many tournaments to follow. Your team can reserve a spot in the Pro Arn by filling out the entry form and sending it in with a \$100 deposit or full payment of \$340. If you send in just the deposit, the remainder is to be paid on Friday night at the registration. All entries postmarked by August 9th will be put into our lottery drawing for starting positions. If the field is not full, entries received after August 9th will be assigned starting position by the order received.

Registration will be on Friday night at Shotski's Bar in Eagle River starting at 5:30pm. Live Facebook welcome will be done at 7:30pm on Friday night. All tournament updates will be done via Facebook along with Saturday's standings being posted at Shotski's on Saturday night. Sunday afternoon's awards will begin at 2:00pm at Shotski's. This will also take place live on Facebook at 2:00pm. Takeoff both days will be at 7:30am at the north end of Eagle Lake at the park.
